- 1. State requires completion of a State Approved Protocol Course prior to issuance of licensure through reciprocity.
- 2. The State of California credentials the paramedic level; however, EMT and AEMT applying for licensure are directed for credentialing through the local EMS agencies.
- 3. Connecticut requires paramedic applicants to receive a Mental Health First Aid training program prior to issuance.
- 4. AEMT N/A references states that do not currently identify Advanced EMT (AEMT) as a licensure level within their governing body.
- 5. The state of Oklahoma requires the individual applying for the Advanced EMT level to have a NREMT psychomotor examination skill verification for endotracheal intubation.
- 6. The State of Oregon requires applicants at the Paramedic level to submit proof of an associate's degree or higher, or proof of active employment at the National Registry Paramedic level for three of the past five years.
- 7. Wisconsin requires students applying for reciprocity to complete a Weapons of Mass Destruction (WMD) course within 6 months of application.
